

## **PlisWeb privacy policy**

*Valid from 25/03/2010*

This privacy policy describes the use and disclosure by PlisWeb of personally identifiable information (full name, address email address, postal address, phone number or banking information), as well as data that could lead indirectly to personally identifiable information that users provide voluntarily to PlisWeb when they register.

This privacy policy applies to the services offered by PlisWeb, including any URL address under rule [www.plisweb.com](http://www.plisweb.com) or those subsidiaries of the same (jointly the "PlisWeb services").

The PlisWeb services are hosted in the United States. If you are outside of the United States, you expressly accepts that related data and personally identifiable information will be transferred to the United States for the purposes described in this privacy policy, as a result of your use of the PlisWeb services.

The website PlisWeb is directed to the public in general and does not intentionally collect information of Personal identification and related data from children under 13. Eventually, PlisWeb may amend this privacy policy to reflect industry initiatives or changes in the law, our practices for collection and use of personally identifiable information or data related, the functions of the PlisWeb services technology, and such modifications will become force of his publication of PlisWeb on the web site. Continue using the PlisWeb services of a privacy policy revised PlisWeb publication implies that you accept such revised privacy policy. It is important that you review this privacy policy regularly to ensure information updated on any changes. If PlisWeb makes a substantial change in its practices regarding collection or use of your personally identifiable or data related information, your personally identifiable and data related information will continue to be governed by privacy policy in which collected, unless you have notified this change and you have not objected.

### **COLLECTION AND PRESENTATION OF INFORMATION OF IDENTIFICATION PERSONAL E INFORMATION OF IDENTIFICATION NOT STAFF IN PLISWEB**

#### General information

Only PlisWeb collects personal or tax information at the time to register as a user in our service. Such data include: management of email, name and last name, zip code, date of birth, trade names and banking data (depending on the method of payment) in order to register you as a user service.

In addition, PlisWeb collects identification information not Personal including IP address, and other data related global data of the user and browser type. This data is used to administer and improve the PlisWeb services, track usage, and security purposes. As a user of the services of PlisWeb, you responsible for the content stored in the contracted web space.

At all times, PlisWeb can access the information stored in web spaces created by users, and in limited cases, also may make certain third parties authorized by PlisWeb, for the purposes of ensuring compliance with the terms use PlisWeb.

PlisWeb determines the end of the collection, use and disclosure of web data which you provide and as such, it is considered the owner responsible for this information. Because the user, not PlisWeb, determines the purposes for which it is collected, used and it disseminates information web spaces, PlisWeb is not the holder responsible for data information from website users manage in PlisWeb.

#### Cookies (or Shared Objects)

Cookies are small pieces of information PlisWeb saves on your computer. PlisWeb uses cookies to store temporary files to speed up the process of development of your web space. The data within cookies can be read to authenticate user sessions or provide services.

You can schedule your computer to tell that a cookie is being sent, block third party cookies or block all cookies. However, by blocking all cookies we can not have access to certain functions of the PlisWeb services.

## **NOTIFICATION: PLISWEB WILL BE NOTIFIED ABOUT THEIR PRACTICES OF COLLECTION OF INFORMATION OF PERSONAL IDENTIFICATION**

When you provide personally identifiable information voluntarily PlisWeb, ensure that it is informed of who collects information, how and why it collects the information and the types of uses that PlisWeb will make of the information that they differ from what is allowed pursuant to this privacy policy.

At the time your personally identifiable information provided in that PlisWeb will notify your options regarding our use of your personally identifiable information (see "Options" below). Except as described in this privacy policy, PlisWeb does not share your personally identifiable information with third parties (except those referred to in this privacy policy) unless you granted permission to PlisWeb to do so (see "Use" below).

It is possible that the PlisWeb services contain links to Web sites operated by other companies. It is also possible that the PlisWeb services contain advertisements from other companies.

It is also possible that the PlisWeb services has third party created by third developers applications. Third party applications are small pieces of software, often with interactivity, that can be installed on the users web spaces. PlisWeb does not control the third developers, and cannot determine their actions. When a user enters an application from a third party, that user is interacting with the third Developer, not with PlisWeb.

*PlisWeb encourages users to not provide personally identifiable information to third-party application unless the user knows the party with whom it is interacting.*

## **OPTIONS: PLISWEB WILL PROVIDE DIFFERENT OPTIONS WITH RESPECT TO THE USE OF PERSONAL IDENTIFICATION INFORMATION**

With the exceptions provided for in this privacy policy, PlisWeb will obtain your consent before using the personally identifiable information that you provide to us for a purpose other than for which it was granted or communicate their personally identifiable information with third parties who are not affiliated with PlisWeb.

## **USE: USE OF INFORMATION OF IDENTIFICATION STAFF PER PART DE PLISWEB**

PlisWeb will only use the personally identifiable information that you provide under this privacy policy in accordance with this privacy policy. PlisWeb obtains personally identifiable information of a third party as a business partner, our use of that information is also governed by this privacy policy.

Employees, agents and contractors of PlisWeb must have a commercial justification to gain access to your personally identifiable and data related information. PlisWeb can share your personally identifiable and data related to those who help us manage or provide activities related information services PlisWeb (e.g., fulfillment of orders, statistics analysis, data processing), or contractors, agents or sponsors outside to help us with the aspects of administration.

These contractors, agents or sponsors outside can temporarily store information on their servers, but can only use your information personally identifiable to provide PlisWeb a specific service and for any other purpose.

PlisWeb can also provide your personally identifiable information to a third party where you have chosen to receive certain information and have been notified that, to meet such a request, is necessary to share your personally identifiable information.

There may be cases in which PlisWeb may access or disclose personally identifiable information data related information a web site or information of no Personal identification without providing another option for:

- (1) protect or defend the legal rights or property of PlisWeb or its employees, agents and contractors (including enforcement of our agreements)
- (2) protect the safety of the users of the PlisWeb services or users, including acting in urgent circumstances
- (3) protection against fraud or for risk management purposes
- (4) comply with the law or the process legal.

Moreover, if PlisWeb sells all or part of its business or makes a sale or transfer of all or a substantial portion of its assets, or is involved in a merger or transfer of all or a substantial part of its business, PlisWeb may transfer your personally identifiable information to the party or parties involved in the transaction as part of that transaction.

When a user chooses to publish web information disseminated publicly, that user is responsible for ensuring that such information will comply with all local data protection laws. PlisWeb is not responsible for the information published by users pursuant to any law on data protection.

#### **SECURITY: PLISWEB PROTECTS THE SECURITY OF THE PERSONALLY IDENTIFIABLE INFORMATION**

PlisWeb takes administrative, technical, personnel and measures physical commercially reasonable to protect personally identifiable information and information about bank details that are in its possession against loss, theft, and use, unauthorized disclosure or modification. In addition, PlisWeb uses reasonable methods to ensure that personally identifiable information is accurate, and up-to-date and complete properly.

#### **ACCESS, REMEDIES AND COMPLIANCE: HOW TO ACCESS, CORRECT OR CHANGE YOUR PREFERENCES WITH RESPECT TO YOUR PERSONALLY IDENTIFIABLE INFORMATION AND HOW TO CONTACT A PLISWEB ON PRIVACY ISSUES**

Wherever possible, the PlisWeb users can review the registration information we hold in our records. We will take reasonable steps to correct the registry information that users inform us is incorrect. If requested to PlisWeb that disrupt the use of your personally identifiable information, PlisWeb will respect this request that it will retain any record of your personally identifiable information necessary to comply with applicable federal, State or local laws.
